

**TO REQUESTER OF BOARD MEMBER PETITION:**

Petitions are due on **Monday, April 20, 2020, by 4:30 P.M.**, to the District Clerk (Hilderbrandt Building – directly behind Saugerties Jr/Sr High School).

**Twenty-five ( 25 )** signatures of qualified voters are required; however it is recommended that you have at least 50 signatures in case some signatures cannot be verified.

The drawing for name position on the ballot will take place at 11:00 a.m. **on Tuesday, April 21<sup>st</sup>** in the Superintendent's Office. Please consider this your invitation to attend.

## PETITION INFORMATION

1. All addresses must show street and city (No PO Boxes or they will be disqualified). It is not necessary for STATE and ZIP CODE to show.
2. Each person must print their name and sign individually, one name per line. (No Mr. and Mrs. Smith – first name and last name only). **The printed name must be legible.**
3. You are required to complete a campaign expenditure form (attached to your petition) and hand it in with your petition in the Hildebrandt Office **on or before** 4:30 p.m. on April 22, 2020. **YOU ARE REQUIRED TO COMPLETE THIS SAME FORM TWO (2) MORE TIMES AND HAND IT IN ON MAY 14<sup>TH</sup> AND AGAIN ON JUNE 8<sup>th</sup>** (whether you've been elected or not). If you'd like, as one of the secretaries in the Hildebrandt Office is a Notary Public, your campaign expenditure forms can be notarized provided you bring them in personally before 4:00 p.m,
4. ***On April 21<sup>st</sup> at 11:00 a.m. in the Superintendent's Office a drawing will be held to determine name position on the ballot. Please consider this your invitation to attend.***
